

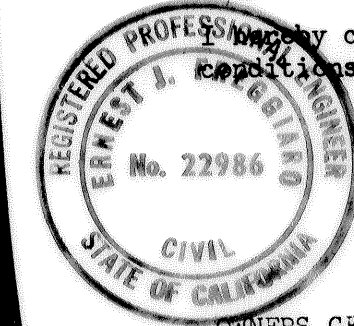

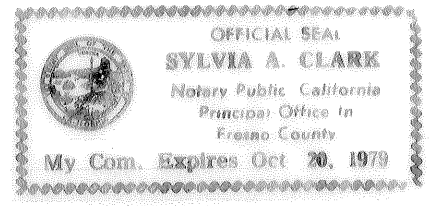
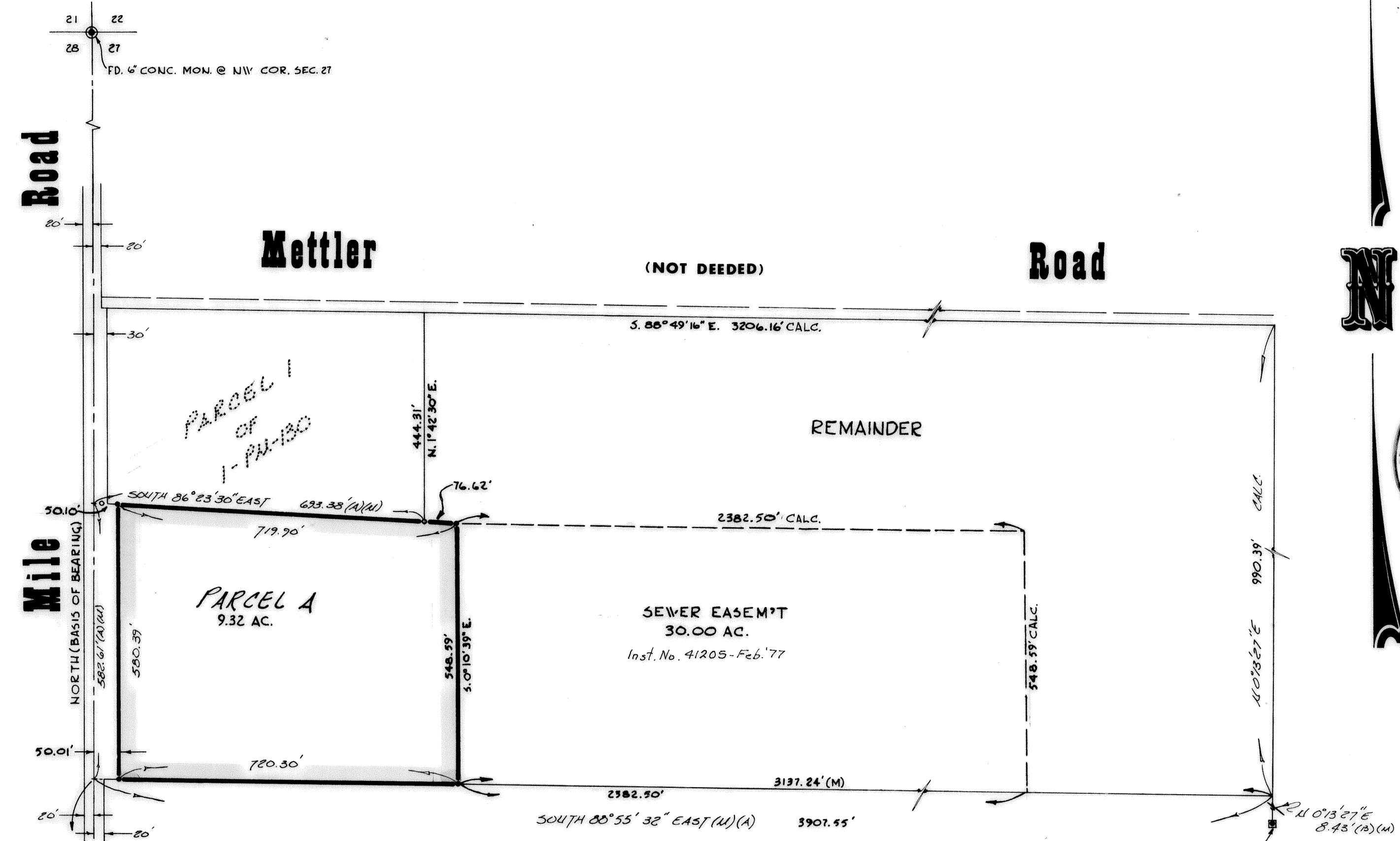
PARCEL MAP

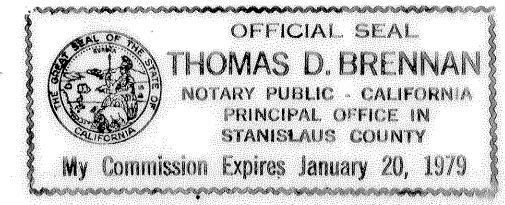
